MARCH 2013

25th Anniversary Program & Celebration (Passed)

This CLE program and reception on March 7 commemorates Chicago Committee's 25 years as an organization and marks the Committee's renewed focus on accelerating the progress of diversity in our profession. The CLE Program is the fourth in Chicago Committee's Diversity Speaker Series. It will be held at the James D. Parsons Memorial Courtroom at the Dirksen Building and is in two-parts: Part I is an original statistical analysis of the progress of diversity in the legal profession over the last

decade, nationally and in Chicago, based on original research by Professor William Henderson at Indiana University Maurer School of Law in collaboration with NALP. Professor Henderson will also offer solutions that are aligned with the Committee’s reformulated Talent Development Initiative (TDI). Part II is an oral argument on the same topic (progress or not) by two Chicago Committee Board members before a distinguished hearing panel that includes: Honorable Virginia Kendall, U.S. District Court Judge for the Northern District of Illinois; Cesar Alvarez, Executive Chairman, Greenberg Traurig, LLP law firm; and Gail Hasbrouck, SVP, General Counsel and Corporate Secretary for Advocate Health Care. A reception follows the program, from 6:00 – 8:30 p.m., at the Rookery Building, 209 South LaSalle Street. Arne Duncan, U.S. Education Secretary, is our outstanding guest speaker.

September - October 2013

First Annual “Rate My Pitch!!!”

Relationship building is a critical competency for associate development, including internal firm relationships with partners and practice leadership as well as external relationships with firm clients and broader business communities.

This pilot program is a 3-evening series that will provide instruction and experiential learning for approximately 20 member firm associates who have practiced for between 4 and 7 years. The goal is to replicate the program going forward and offer it at least annually. Program participants are determined by application to Chicago Committee and by random lottery, with consideration given to Board recommendations, to AB members and to ongoing engagement of all of the Committee’s member firms. The program’s overall intended outcome is to facilitate extensive participation by the associates while providing meaningful feedback and learning.

The learning plan includes five real life scenarios that associates might encounter: (1) taking a partner or practice leader to lunch with an identified objective, (2) transforming a college or high school friendship into a business relationship, (3) taking advantage of an ad hoc encounter with an existing firm client to market yourself, (4) a “cold call” on a business acquaintance introduced by a mutual friend and (5) making a formal business pitch as part of a group in response to an RFP.

Associate participants will work in teams. Sessions I and II are instruction and practice sessions using the above described scenarios with coaching provided by member law firm partners. Session III is a team business pitch in response to an RFP to a panel that includes in-house counsel and business professionals with marketing experience, followed by a feedback and discussion session. We will recognize participants based on performance pertaining to identified competencies, e.g., established rapport, instilled trust, met identified objective, etc. The prizes are opportunities for a breakfast or lunch meeting with a panel member.
